Special Presentation

1st Sergeant Ray Cordani commented that Officer Jordan McBride recently responded to a 911 call reporting an unresponsive person that may have overdosed. Officer Jordan was on scene within minutes and found the person laying on the floor, not breathing and with an undetectable pulse. He immediately began administering doses of Narcan and was able to revive the person. For the actions taken by Officer McBride 1st sergeant Ray Cordani presented Officer McBride with a Letter of Commendation and Life Saver Award, which was presented to him during a Stillwater Town Board meeting.

Presentations

Bocrest Field: A representative from CT Male Engineers gave a brief overview on the proposed Planned Development District. The applicant is proposing a PDD to include apartment style residential development, single family lots and a land conservation area.

Hudson Heights Apartments PDD Amendment: A brief presentation was given on the proposed amendments to the Turning Point PDD pertaining to the Hudson Heights Apartments site plan. The proposed PDD amendment makes a series of technical changes to the PDD as it pertains to the Multi-Family Apartment phase, along with provisions for alternate parking scheme.

Saratoga Glen PDD Amendment: A representative form ABD Engineers gave a brief presentation of proposed amendments to the Saratoga Glen PDD. The proposed changes would include construction of 3 apartment buildings with a total of 26 units to accommodate residential demand in the area. The existing land was originally intended for commercial development.

Local Law Presentation-- Adult Use Cannabis Retail Dispensaries and On-site Consumption Sites

Attorney Pezzulo gave a power point presentation of the new state laws regarding Marijuana use.
