Resolution No. 57 A Resolution Authorizing the Supervisor to Sign a License Agreement with Verizon Wireless for a Temporary Monopole

WHEREAS, the Town has previously approved the demolition of the Riverside Water Tank and Tower on West Street and it is no longer needed for water supply purposes; and

WHEREAS, the Riverside Tank currently has telecommunications equipment on it owned and operated by Verizon Wireless ("VZW") which needs to be moved to a temporary monopole and then to a more permanent monopole in order to ensure continuous coverage in the future; and

WHEREAS, a License Agreement between the Town and VZW is appropriate to allow VZW to utilize a portion of the Town's property on West Street to install the temporary monopole.

NOW, THEREFORE, BE IT

RESOLVED, that the Supervisor is hereby authorized to negotiate and sign a License Agreement so Verizon Wireless can utilize a portion of the Town's West Street property for a temporary monopole in order to continue utilizing its telecommunications equipment currently located on the Riverside Water Tower.

WHEREAS, the Town proposes to consolidate the two parcels, make further site improvements and construct a public safety facility; and

WHEREAS, Town Engineer Paul Male, P.E. has investigated the potential environmental impacts of the proposed actions, has compiled the attached Environmental Assessment Form ("EAF") and recommends the proposed actions be classified as Unlisted Actions and a negative declaration be issued.

RESOLVED, that the Town Board has compared the proposed action with the criteria for determining significance in 6 NYCRR 617.7 (SEQRA), has duly considered the attached Environmental Assessment Form, classifies the parcel consolidation, the site improvements and the building construction as Unlisted Actions, and finds the environmental impact of those actions not to be significant and hereby issue a negative declaration.

Resolution No. 60 A Resolution Authorizing the Supervisor to Negotiate and Sign a Temporary License and Easement Agreement Regarding the Riverside Water Tower Demolition

WHEREAS, the Town has previously approved the demolition of the Riverside Water Tank and Tower on West Street by DSA Services as it is no longer needed for water supply purposes; and

WHEREAS, because of the small size of the parcel, DSA Services requires a separate area to laydown materials and equipment while the water tower and tank are being dismantled; and

WHEREAS, the driveway into the Town's Riverside parcel is shared with an adjacent property owner; and

WHEREAS, the owners of the adjacent parcel have agreed to exchange driveway easements and to provide the Town with a portion of their property for the temporary laydown area.

NOW, THEREFORE, BE IT

RESOLVED, that the Supervisor is hereby authorized to negotiate and sign a License Agreement with the Ciulla Family at 47 West Street for a temporary laydown area for materials and equipment during the demolition of the Riverside Water Tank and Tower; and be it further

RESOLVED, that the Supervisor is also authorized to negotiate and sign easement agreements with the Ciulla Family at 47 West Street for shared use of the driveway that straddles both properties; and be it further

RESOLVED, that this resolution is subject to permissive referendum under the New York State Town Law, such that the Town Clerk is required to post a Notice of the adoption of this resolution in the Town's official newspaper, on its website and on the Town bulletin board within 5 days of its adoption.

Resolution No. 65 A Resolution That the Town of Stillwater will Submit an Application and Serve as Lead Agency for a Joint Application for BOA Designation, in Cooperation WHEREAS, The Town of Stillwater, New York, herein called the "Applicant", after thorough consideration, has hereby determined that certain work, as described in its application and attachments, herein called the "Project", is desirable; and

WHEREAS, §970-r of the General Municipal Law authorizes State assistance to eligible parties for Brownfield Opportunity Areas Program grants by means of a State Assistance Contract (the contract); and

WHEREAS, the Town of Stillwater, New York deems it to be in the public interest and benefit to enter into a contract therewith.

NOW, THEREFORE, BE IT RESOLVED BY

The Stillwater Town Board

- 1. That Ed Kinowski, Supervisor of the Town, is the representative authorized to act on behalf of all applicants in all matters related to State assistance under §970-r of the General Municipal Law for the Project. The representative is also authorized to: sign and submit the application; execute the contract; request payment advances and reimbursements; redistribute contract reimbursements as appropriate; submit Project documentation; and otherwise act for all applicants in all matters related to the Project and to State assistance;
- 2. That the Applicant intends to complete Nomination for an approximate 450-acre area characterized with approximately 7 to 9 potential brownfield sites, along with numerous vacant and underutilized sites, in both the Town and Village of Stillwater, hereafter to be referred to as the Stillwater Riverview BOA.
- 3. That the Applicant requests funds in the amount of \$200,000, representing no more than 90% of the total Project costs;
- 4. That the Applicant agrees that it will fund the Applicant's minimum required 10% share of the Project;
- 5. That the Applicant agrees to complete the BOA Nomination in a timely manner and to seek official Designation of the Brownfield Opportunity Area by the Secretary of State upon completion of the Nomination; and
- 6. That this Authorization take effect immediately.
