James Trainor stated that local meetings will allow remote attendance at board meetings. It's a change to the town code, and a public hearing will be scheduled on October 20,2022 at 7pm at Town Hall in Stillwater NY.

The remote board member cannot be the quorum vote, they will need to be #4 or 5 and that the board member must been seen by the public. State allows to attend remotely if they have a disability.

Supervisor Kinowski- Budget adjustments and corrections are stated at the end of the year. If anyone would like a copy please request from the Town Clerks office.

PSB – Supervisor Kinowski spoke of the expenses and interest rates rising. Valerie Masterson asked about the PSB increasing up to 5 million expense on the building. Supervisor Kinowski answered: Main aspect is the ambulance building is in bad shape. Same thing with the police department's building needs to be expanded. Not enough room for current files and locker rooms etc. Court system needs more space as our building dept. is growing and they need more space for storage. Build the building for the future. It will build more space at the Highway Dept. and here at the Town Hall. Ambulance response time in new building will be equally the same.

James Trainer- Local Law #6 should be on Resolution 77 and Local Law #7 should be Resolution 82.

Town Budget- Councilwoman Masterson would like to add \$2500.00 for an Electronics' Day in the 2023 budget.

Upcoming meetings- Supervisor Kinowski and the Board agreed upon canceling the Oct. 6th meeting so the Board Members can attend the Economic Summit.

October 20th meeting will be the Working Budget meeting.

November -1^{st} meeting will be the preliminary voting on budget. Budget workshops will start at 6pm as a special meeting before regular meetings.

Kinowski recognized Highway dept. for responding quickly to yesterday's water breaks. A shout out to Clayton, Sue and Highway Dept. with doing a phenomenal job with the new playground on Riverside Park.

Looking to open end of July 2023. 4.5 million for 1.25% interest. In 2025, we have 2 bonds that will be due and when that happens, it will provide us with more money.

Supervisor Kinowski will send out request on proposal to the Board for repairs on the SACC building. He also stated, Kudos to the SACC staff for saving the Gym floors!
