# 5.) Public Input

Josie, resident from Brickyard Rd. stated it is not mandatory to have pubic sign in to attend a public meeting. She then proceeded to hand out copies of the State of New York Department of State Committee on Open Government to the Town Clerk, the Town Attorney and Town Supervisor. See attached.

Adam, a resident on Native Dancer Lane, briefly stated issues with the SGH water Supply in their neighborhood. He did attend the August town board meeting when it was suggested to start a petition and he did just that. He handed the Town Clerk a petition with 50+ signatures on it, asking the town for their support with assisting with the quality issues and inconsistent problems. He would like some action taken and asked what options are available to fix this?

Supervisor Kinowski responded with taking the petitions and discussing it with engineers and town attorney and will get back with him by the next meeting or two. In the meantime, take pictures of your meter and track it.

Dick from County Rte. 76 questioned the PSB and wanted to know if all employees are moving up to new facility.

Supervisor Kinowski responded with Police, EMS and the Court will be moving up there. There is an embankment there for a reason and that reason is for future building.

Kelly, resident from Mitchell Road, questioning why public comments are not published in the meeting minutes and asking for minutes to be recorded. She also is requesting the Town Board to hold a public hearing to inform all residents of the wide scale of upcoming projects, etc. See attached written comments from Kelly Carpenter.

Danielle Cowin, Town Clerk, replied to resident, by informing them the minutes need not be a verbatim transcript, according to the NYS Town Clerk Manual. The state comptroller's office has opined that the town clerk's duty to keep a complete and accurate record is not a statutory requirement to keep a verbatim record.

Supervisor Kinowski replied with it is difficult to address with getting the whole town to attend and establish parameters.

Josie, Stillwater resident, questioned streamlining meetings.

Councilman D'Ambro answered with we have tried that and no one attended. And further on, discussed the project processes. Most projects are in progress 5-7 years and start with the Zoning Board, Planning Board and then to the Town Board. He recommends attending those meetings for information and follow progress.

Councilwoman, Masterson suggested meeting as a board to discuss what we can do and as an elected official, its pertinent to us to reach out to the community.

Kelly also questioned, how the planning board notifies the residents of upcoming meetings. The Town board replied with; through the town's website, social media and in the town's newspaper, The Express, with public notices, workshops, public hearings, etc.

# 6.) Other Business

Supervisor Kinowski reported all contracts for the Public Safety Building have been signed. This is the 1<sup>st</sup> ever that something has been built and the 1<sup>st</sup> of its kind in our Town of Stillwater. He proceeded on to say it took a level of effort from everyone. Pictures will be provided to the public and scheduling a ground break opening within the first few weeks of December.

Supervisor Kinowski invited everyone to please reach out to him and set up appointment if they would like to discuss anything.

Councilwoman Masterson shared dates have been set for Town Wide lean up Day. May 6<sup>th</sup> and October 14<sup>th</sup>, 2022. She also stated that she is working on an Electronics Day for June 2023.

In closing, Supervisor Kinowski, thanked all employees, Police and Highway Dept. For their hard work during the pandemic. Our offices were never closed and we coordinated a grand supply of free covid test for our residents.

# Good evening-

I'd like to take a minute to introduce myself for those of you who don't already know who I am. My name is Kelly Carpenter. I've lived in Stillwater all my life, as well as both of my parents and both sets of grandparents. I have two boys who attend Stillwater School, and I live on 21 Mitchell Road, just feet from a project currently in the works, courtesy of Bocrest Fields.

I'm here tonight to comment publicly on a few things, ask some questions, and make a request of the board.

13 years ago I bought my home. Shortly after, I found myself sitting in a town board meeting, just like this one, where Ed Kinowski spoke to the residents. The topic was a multi-use trail that runs from the village through the town, all the way to the train tracks on Frog Island. The discussion was about expanding the trail, connecting it to various others in neighboring communities.

Ed was passionate about the trail. Afterall, it is a beautiful place, surrounded by nature **currently** on all sides. He stated that trail would be a place of environmental tourism, where families could escape to walk their dogs, ride their bikes, and relish in nature.

Not once in that meeting and nowhere in that plan was it stated that adjacent to that natural sanctuary there would eventually be a 312 unit, 13 building, 3-story high complex, that would destroy the area, eliminate wildlife and most importantly encroach upon wetlands which should be protected by people in the position to do so.

I have to ask, where in this community is there another apartment building three stories high? I think we'd be hard-pressed to find one. Something like that doesn't fit in to the fabric of our small town. It isn't needed, and it certainly isn't wanted. The location is all wrong, the size is all wrong and the height.. ALL WRONG.

What has changed? Why isn't that path and that area seen in the same light it was 13 years ago?

Following the last Planning Board meeting, I started a petition – a petition opposing the Bocrest Fields 312 unit, 13 building, 3-story high apartment complex because I wanted the board, the people we put our trust in to make the right decisions for our town and village, to see just how many people oppose this project, but since then it has become so much more than that.


Headed our way, we have over 1,000 apartments either already approved for development or close to being approved. This petition that now has close to 700 signatures (and climbing daily) is a testament to how our community feels about what's coming as a whole.

In closing, I'm requesting and would greatly appreciate (as would so many here tonight) for someone on this board to motion for a public hearing – a public hearing to be held in which the town, in full transparency, informs ALL residents, not just those within 500 feet of an individual project, about all currently approved building projects and proposed development plans.

We need a public hearing about the large scale development that is in the works for Stillwater. Seeing projects on a case by case basis does not even remotely highlight the massive changes that are coming to both the village and town.

The residents of Stillwater have the right to know what's on the horizon and should be given the opportunity to speak up for OUR small town, OUR Stillwater.

# **Comments shared at the Nov 3rd Town Board Meeting:**

Our Community published a well thought out and organized Town Comprehensive Plan in March 2021, which projected 934 units by 2025. Those units were 81% single family and 19% apartments.

From the list that I have been able to pull together, there are currently 1,339 planned developments approved by the Town Board and in various phases of the planning process. The approved projects are 143% higher than the plan and effectively **double the number of apartments** in our community. Currently approved projects are **80% are apartments**, 10% condos, **10% single family homes.** 

Assuming 2-2.5 people per unit, and our current population of 9500, this is a **28-35% increase in population**. It will also generate around 2,000- 2,700 additional cars on our roads. (1.5-2 cars per unit).

Again, the town comprehensive plan had 81% single family homes and the **current approved project list is 80% apartments.** What actions are being taken to address the changes between the Comprehensive plan and our current approved projects? Has there been a consideration around the change in tax base as apartments are taxed at a lower rate?

The comprehensive plan also calls out that with growth comes a commitment to community services such as police, fire protections, schools and other infrastructure. Ed/Town Board, please share the Town's infrastructure assessment and plans in place to manage the 28-35% increase in population.

I requested a list of the approved projects/developments from the town so that we can be as accurate as possible when we talk about these projects in an open and transparent forum. Initially I was told that my questions would be answered by email and then after the planning board meeting, I was told that I needed a foil request. My submitted request was denied.

The exact wording on my FOIL request is below as well as the response from town:

- 1. A list of all approved building projects. **Response:** No such record exists of the type described
- 2. Status of approved projects (ie. not yet built/in process) **Response:** No such record exists of the type described
- 3. How many units in each project and type of unit **Response**: No such record exists of the type described
- 4. An electronic copy of the traffic study for Bocrest fields. **Response: Email with study**

What is the correct path to get the requested data?

Lastly, I am requesting that **all** Public Hearing Notices be published on the Town Website and Facebook site at least 5 days ahead of a meeting to bring visibility and transparency to our community. Currently, these are mailed only to residents within 500 feet of the proposed development and posted in the Express, which is not a broad enough communication.

Over the years, my community has frequently encountered issues with inconsistent billing and an overall lack of transparency and accountability from SGHWSC. Additionally, some members of our community have raised concerns with the poor quality of water excuses, I would like the Town of Stillwater to explore what other alternatives are available to provide water services to my home they receive from this utility company. After attempting to deal directly with SGHWSC and receiving numerous promises and and to approve the funds necessary to commission a map, plan and report.

Completing a map, plan and report will enable our community to effectively evaluate the alternatives to our current water service in costs to these alternatives, and service boundaries on a potential Town Water District. I understand that producing a map, plan and report does not obligate myself, the Town or its residents to make any type of decision or commitment to the results of this report. A map, plan and report will allow residents in our community to examine possible alternatives to SGHWSC, provide an estimate on order for us to make an informed decision on how to best proceed.

I'd just like to understand a bit more about the meeting minutes that were just approved from 11/3. Did they include a comprehensive list of all feedback from residents present that evening?

My concern is that neither my comments nor Nicole Oliver's were fully reflected in what was published on the town's site. In fact, the entire write-up I read that evening was handed over to you and still didn't make it's way into the minutes.

However, yesterday, the letter that I read and all of Nicole's comments, including those that were left out of the meeting minutes, were emailed to ensure that what we stated made it's way into those published minutes. We'd like to ensure that an accurate depiction of our comments is reflected for public record.

Most importantly, I'll restate something that should have been recorded for public record and wasn'tyin hopes that it will be recorded tonight – and that is my request for the town to hold a public hearing, and I'll reread what was read on 11/3:

"I'm requesting and would greatly appreciate (as would so many here tonight) for someone on this board to motion for a public hearing – a public hearing to be held in which the town, in full transparency, informs ALL residents, not just those within 500 feet of an individual project, about all currently approved building projects AND proposed development plans.

We need a public hearing about the large scale development that is in the works for Stillwater. Seeing projects on a case by case basis does not even remotely highlight the massive changes that are coming to both the village and town."

And moving forward, if we need to provide written comments to ensure they make it into the minutes for an accurate reflection, please let the public know, so we can be sure to provide that.
