WHEREAS with best efforts to continue our solid procession of exceptional Highway Superintendents, the Town Board here by recommends another truly skillful and equally dedicated individual to replace Mr. Harris for the remainder of his elected term. WHEREAS the Town Board therefore wishes to appoint William Doughty as the Town Highway Superintendent effective on August 30, 2024 to fill the remainder of Mr. Harris' term through December 31, 2025. Mr. Doughty comes to this position with 25 years of experience and knowledge of our Town resources. Public Input

T. Campbell, resident, asked about the dates for E-waste and Fall clean up.

Councilmember Weaver replied, the Town Wide Clean up will be on October 12th and E-Waste will resume on September 7th. There are no fees for the residents for E-Waste as the Town pays the \$125.00 a month for the storage unit. Enter and exit signs are needed for vehicles coming and leaving during E-Waste drop offs.

Mayor Judy Wood-Zeno announced a competition that the village is holding for residents. They were asking for residents to come up with naming a park the village just recently purchased. They currently have over 60 names to vote on. Closing date for voting is August 31st. The village park will consist of the following amenities: cement slab deck, picnic tables, power, kiosk, maps, and business information.

Other Business

Supervisor Kinowski reported Browns Beach will be closing the beach because water testing levels are high and we need two good days of good levels to reopen.

Councilmember Vomacka noted she has not heard back from the roofing contractor, therefore moving forward with other contractors.

She had attended the Saratoga Plan meeting on Snake Hill. They value the input of the community members as they consider future management and uses of Snake Hill. Councilmember Vomacka suggested taking a look at their website for more information.

Town Clerk

Clerk Cowin announced the town clerk's office will be promoting "mandatory licensing your dog in NYS" by conducting a dog of the month contest. Residents will have an opportunity to send in a photo of their dog. Town employees will judge the best dog and win prizes for that month.

She also noted the list of family day events happening on Saturday September 14th from 11am to 10pm.
