Resolution No. 61-66

Public Hearing:

Joe Lanero, Engineer for La Bella, presented on the map plan and report for water district #7 formation. The Town of Malta purchased private water company (Saratoga Water Service, Inc. and formed Town of Malta Water District 7. There is a total of 3025 properties that will be served by this water system and 147 of them are located within the Town of Stillwater. The purpose for the formation of the proposed water district #7 is to service our 147 residents through and IMA (Intermunicipal Agreement) between the Town of Malta and Town of Stillwater.

WHEREAS, prior to adopting the annual plan for 2025 which establishes local policies for the administration of the Section 8 program, a public hearing is required on the proposed plan.

RESOLVED, that a public hearing is hereby scheduled for 7:00 p.m. on January 16, 2025, at the regularly scheduled Town Board meeting for that evening at Town Hall, 881 Hudson Avenue, Stillwater, New York 12170; and be it further

SEQRA Resolution regarding the Formation of Water District #7

WHEREAS, the Town Board has compared the proposed action with the criteria for determining significance in SEQRA 6 NYCRR 617.7 and has duly considered the Environmental Assessment Form previously prepared by LaBella when the application was submitted; and

WHEREAS, the Map, Plan and Report dated September 2024 indicates no significant environmental impacts as a result of the proposed water district extension formation; and

WHEREAS, a Public Hearing was conducted at the Town Board meeting on November 21, 2024, at which time the environmental impacts of the project were presented and discussed.

Now, therefore, be it

RESOLVED, that the Town Board as lead agency has determined that the proposed Formation of Water District 7 is an Unlisted Action pursuant to 6 NYCRR Part 617 (SEQRA) and finds pursuant to the criteria in Part 617.7 that the proposed action will not have a significant adverse environmental impact and hereby issues a negative declaration.

Resolution No. 63

Resolution Approving the Formation of Water District # 7 Introduced by: Supervisor

WHEREAS, a Map Plan and Report, ("MPR") dated September 2024 provided by LaBella on behalf of The Town of Stillwater (the "Town"), has been filed with the Town Clerk requesting the approval of a water district to be known as Water District 7 (the "District") as more particularly described in the MPR attached hereto; and

WHEREAS, a certified copy of the Resolution of this Board calling for a hearing thereon, which Resolution is dated October 17, 2024, which is incorporated herein, was duly published on notice by the Clerk as set forth in an Affidavit of Publishing and Posting; and

WHEREAS a Public Hearing was held at 7:00 PM at Town Hall, 881 Hudson Avenue, Stillwater, New York on November 21, 2024, to consider the formation and environmental impact of the District pursuant to Article 12-A of the NYS Town Law as described in the Notice of Hearing; and

WHEREAS, the Town Board as lead agency determined that the action is an Unlisted Action pursuant to 6 NYCRR Part 617 (SEQRA), found pursuant to the criteria in Part 617.7 that the

proposed action will not have a significant adverse environmental impact, and issued a negative declaration; and

WHEREAS, the formation of the District is not subject to State Comptroller approval pursuant to §209-f of the New York State Town Law because the cost to the typical property is below the applicable threshold; and

WHEREAS, the transfer of the water system from Saratoga Water Services Inc. to the Town of Malta contained two parcels (SBL 230.-1-21 is the vacant land and SBL 230.-1-21.-1 contains improvements), a special franchise (500.-1-56) and a utility parcel (652.089-9999-239.910-1882); and

WHEREAS, the Town Board has given due deliberation to the comments of the public presented and has determined that the formation of the District is in the public interest.

Now, therefore, be it

RESOLVED, the Town Board finds that the map, plan and report for the creation of the District in the Town is signed, approved, and acknowledged, as required by law, and is otherwise sufficient and complies with the provisions of Article 12-A of the New York Town Law; and it is further

RESOLVED, the Town Board finds that all of the property, property owners and interested persons within said proposed District are benefited thereby, and that all property or property owners benefited are included therein, and that no property or property owners or interested persons benefited thereby have been excluded therefrom; and it is further

RESOLVED, that the District be established in the Town, and will include those parcels of property set forth in the description contained in the map, plan and report; and it is further

RESOLVED, that the infrastructure to be operated by the District currently exists and does not have to be constructed; and it is further

RESOLVED, the cost for operating the District shall be assessed, levied and collected from the several lots and parcels of land within the said District in proportion as nearly may be to the assessed value of each lot or parcel of land in said District; and it is further

RESOLVED, that the creation of the proposed District is in the public interest as more particularly described in the MPR, and it is further;

RESOLVED, no property within the District shall be unduly burdened by the costs associated with the District; and it is further;

RESOLVED, the cost shall be assessed against the whole property, more particularly described in the MPR; and it is further

RESOLVED, that because the transfer of the water system from Saratoga Water Services Inc. to the Town of Malta contained two parcels, a special franchise (500.-1-56) and a utility parcel (652.089-9999-239.910-1882), upon the formation of Water District # 7 the special franchise and the utility parcel are eliminated and the two remaining parcels (SBL 230.-1-21 is the vacant land and SBL 230.-1-21.-1 contains improvements) are hereby declared to be tax-exempt; and be it further

RESOLVED that this Resolution is subject to a permissive referendum pursuant to Article 7 and §209-e of the New York Town Law and the Town Clerk is directed to post and publish a Notice of Adoption of this Resolution in the Express within 10 days.
